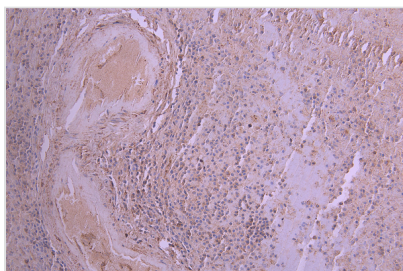

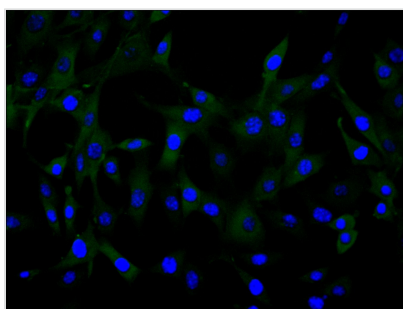

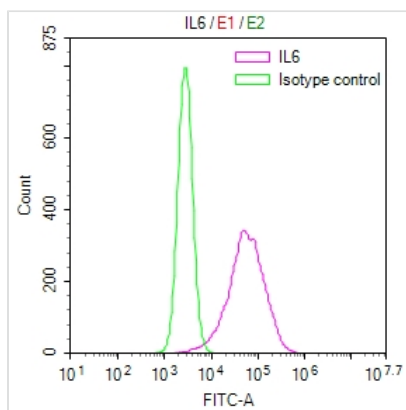
IHC image of CSB-RA011664MA3HU diluted at 1:50 and staining in paraffin-embedded human tonsil tissue performed on a Leica Bond™ system. After dewaxing and hydration, antigen retrieval was mediated by high pressure in a citrate buffer (pH 6.0). Section was blocked with 10% normal goat serum 30min at RT. Then primary antibody (1% BSA) was incubated at 4°C overnight. The primary is detected by a Anti-Human IgG, Fcy Fragment Specific labeled by HRP and visualized using 0.05% DAB.



IHC image of CSB-RA011664MA3HU diluted at 1:50 and staining in paraffin-embedded human spleen tissue performed on a Leica Bond™ system. After dewaxing and hydration, antigen retrieval was mediated by high pressure in a citrate buffer (pH 6.0). Section was blocked with 10% normal goat serum 30min at RT. Then primary antibody (1% BSA) was incubated at 4°C overnight. The primary is detected by a Anti-Human IgG, Fcy Fragment Specific labeled by HRP and visualized using 0.05% DAB.



Immunofluorescence staining of NIH/3T3 cell with CSB-RA011664MA3HU at 1:30, counter-stained with DAPI. The cells were fixed in 4% formaldehyde, permeabilized using 0.2% Triton X-100 and blocked in 10% normal Goat Serum. The cells were then incubated with the antibody overnight at 4°C. The secondary antibody was Fluorescein (FITC) AffiniPure Goat Anti-Human IgG, Fcγ fragment specific.



Overlay Peak curve showing 786-O cells stained with CSB-RA011664MA3HU (red line) at 1:100. The cells were fixed in 4% formaldehyde and permeated by 0.2% TritonX-100 for 10min. Then 10% normal goat serum to block non-specific protein-protein interactions followed by the antibody (1ug/1\*10<sup>6</sup>cells) for 45min at 4?. The secondary antibody used was Fluorescein (FITC) AffiniPure Goat Anti-Human IgG, Fcγ fragment specific at 1:200 dilution for 35min at 4?. Control antibody (green line) was human IgG1 (1ug/1\*10<sup>6</sup>cells) used under the same conditions. Acquisition of >10,000 events was performed.
