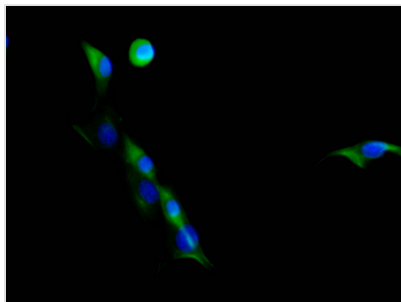




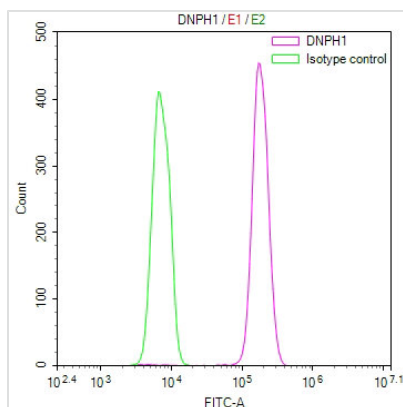
# DNPH1 Recombinant Monoclonal Antibody

<b>Storage</b>	Upon receipt, store at -20°C or -80°C. Avoid repeated freeze.

Immunofluorescence staining of NIH/3T3 cell with CSB-RA207310A0HU at 1:50 , counter-stained with DAPI. The cells were fixed in 4% formaldehyde, permeabilized using 0.2% Triton X-100 and blocked in 10% normal Goat Serum. The cells were then incubated with the antibody overnight at 4°C. The secondary antibody was Alexa Fluor 488-conjugated AffiniPure Goat Anti-Rabbit IgG(H+L).



Overlay Peak curve showing Hela cells stained with CSB-RA207310A0HU (red line) at 1:100. The cells were fixed in 4% formaldehyde and permeated by 0.2% TritonX-100 for 10min. Then 10% normal goat serum to block non-specific protein-protein interactions followed by the antibody (1ug/1\*10<sup>6</sup>cells) for 45min at 4?. The secondary antibody used was FITC-conjugated goat anti-rabbit IgG (H+L) at 1/200 dilution for 35min at 4?. Control antibody (green line) was Rabbit IgG (1ug/1\*10<sup>6</sup>cells) used under the same conditions. Acquisition of >10, 000 events was performed.
