### 4. First Aid Measures

**Ingestion:** If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

**Personal precautions :**No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate.
