### 4. First Aid Measures

**Ingestion:** If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

**Environmental precautions :** Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

**Large spill :** Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas.
