4. First Aid Measures

Ingestion: If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

Skin Contact: If any component of this contacts the skin, flush with copious amounts of water and wash with soap and water for at least 15 minutes. Remove contaminated clothing and shoes. Call a physician if irritation or discomfort develops.

Do not touch or walk through spilled material. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see section 8).

Environmental precautions : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

Large spill : Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Vacuum or sweep up material and place in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor.
